AN EPIDEMIC MOBILIZES A CONGREGATION



Celebrating how a church built a hospital.

In response to an outbreak of typhoid in 1881, a blacksmith's shop would become the first official hospital in Duluth.

Pictured, left to right:

St. Paul's Episcopal Church today; St. Luke's Nursing School class of 1894; Laying the cornerstone of St. Luke's Hospital in 1923. The building, along 3rd Avenue East between Superior and First Street, was donated for use by the Downing family. This humble structure housed a few chairs, three beds and a donated stove. It was here that the tide would turn against the epidemic, beginning a long history of caring for our community.

This hospital, founded by the people of St. Paul's Episcopal Church, was named to celebrate the life of a man the Apostle Paul called "our beloved physician," the

honored doctor, St. Luke.

"St. Luke was a physician by profession," says Trinky Jarrett, granddaughter of John Downing, whose blacksmith shop became the first location of St. Luke's.

"He treated all people, including the poor and oppressed. St. Luke's continues that tradition by ministering to the sick, nursing the young and the infirmed, and providing exceptional medical and spiritual care."

In celebration of the 150th anniversary of the founding of St. Paul's Episcopal Church, and the vital role its members played in St. Luke's establishment, St. Luke's Foundation created the St. Paul's Society, a giving circle open to anyone who chooses to make a planned or legacy gift to St. Luke's.

"The hospital is the center of our community," says Jarrett. "It is a safe, welcome haven for all who enter."

So it was then. So it is now. With your legacy gifts through the St. Paul's Society, so may it always be.



THE NIGHT THAT LASTED ALL YEAR

How St. Luke's helped one man reclaim his life from a frozen river.

In a 1959 Iron River, Wisconsin snowstorm, Stephen Kavajecz was driving home from a farewell party in his honor. He was a week away from beginning a new career at a foundry in Milwaukee when, rounding a curve, he lost control, hitting a concrete bridge before sliding into the frigid river below.

This proud veteran of the Army's 11th Airborne Division, this humble son of farmers, was trapped inside the wreck. He would be there all night.

That's where his story could have ended.

Instead, the icy water kept him alive, chilling his body into a state of hypothermia that reduced his body's demand for oxygen, and thereby extending the time he could survive before medical intervention. The next morning, a snowplow driver found him before it was too late, and he was brought to a hospital that could save his life. That hospital was St. Luke's.

The doctors and nurses slowly raised his body temperature. They treated and healed his wounds. Over the course of a year, the team at St. Luke's helped him relearn how to walk. As one grateful family member put it, "they rebuilt him." Steve went on to a successful

career with the Wisconsin
Department of Revenue in Madison,
Wisconsin, but he never forgot the
dedicated, compassionate people
of St. Luke's and how they saved
his life.

When Steve passed away in 2019, his estate established a nursing scholarship through St. Luke's Foundation in his name, which will provide a new generation of caregivers with funding to support their dream of saving more lives just like his.



PROVIDING WOMEN WITH BRIGHT MOMENTS OF HOPE IN A DARK, DIFFICULT TIME

The stated goal of the St. Luke's Comprehensive Breast Program, under the direction of Dr. Jennifer Witt, is to reduce the time from moment of concern to diagnosis and treatment. There's an unstated goal, as well: To make patients feel seen as people; as women with lives beyond the clinic's walls. The Comprehensive Breast Program works daily to provide women with the advanced care and compassion that can change their lives.

MASTECTOMY CARE BAGS

Sharing Love Through Little Luxuries

It all started with bras. Dr. Jennifer Witt had several patients complain that the ones used in recovery caused too much pain, compression and abrasion. So she went looking for a better option.

"At one point I had 30 bras lined up on a shelf in my office," Dr. Witt says. "It was an intimidating sight." She found an ideal bra made by a company founded by fellow clinicians and began purchasing them for patients. In looking through the rest of the company's offerings, she found a post-surgery mastectomy care bag full of other items a patient would need or appreciate—things like socks and snacks, headbands and dry shampoo. The idea stuck with her.

What happened next is best told by Dr. Witt herself.

"I had a woman in her 20s who was about 24 weeks pregnant when she was diagnosed. I walked her

down into the infusion center on her first day. She walked in and broke down in tears because there was nobody else in their 20s there. Nobody else who was pregnant. And I remember feeling like I wished there was something I could give her, something that could be a bright moment in this dark time. I wanted her to know there are people supporting her. So I bought her one of the company's mastectomy care bags out of my own pocket."

It made a difference for that patient, and Dr. Witt realized it could make a difference for many more.

With the financial support of St. Luke's Foundation, and through curated selections made by past patients, each woman who has breast surgery at St. Luke's is now given a Mastectomy Care Bag. "All of my patients are going through a hard, emotional time," Dr. Witt says. "I thought it would be really powerful to give them something to show they're more than patients to us."



THE NEXT CHAPTER IN EARLY DETECTION

How advanced technology is helping rewrite women's stories.

"Had I not opted for the 3D mammogram, who knows what my story would have been?" -Cheryl Abramson

Cheryl Abramson arrived for her annual mammogram in 2017 and was presented with a choice.

St. Luke's had just secured 3D mammography technology, which was available to patients at an increased cost, as most insurance companies weren't covering the procedure at the time.

"I was fortunate to be in a financial position where I didn't have to think twice about the additional charge," Cheryl says. Being able to say "yes" to 3D may have saved her life. The 3D mammogram detected her cancer earlier than a standard mammogram would likely have been able to do. And Cheryl's story is not unique.

"I have several patients who have had a diagnosis of breast cancer that was made on a 3D mammogram that we don't believe would have been made without it,"

says breast imaging specialist Dr. Kerri Harting. Still, the additional cost of a 3D mammogram was often too high of a hurdle for some women, something Cheryl and her husband Mike were determined to fix. Their gift to St. Luke's Foundation established a fund that covers the costs of a 3D mammogram for every woman who wants one. "A diagnosis is scary enough," Cheryl says. "No woman should have to worry about how they're going to pay for it." 3D mammography is now the standard of care at St. Luke's, in no small part because of the Abramson's gift.

DOMESTIC VIOLENCE TASK FORCE

NEVER AGAIN

In the wake of tragedy, the St. Luke's family comes together to fight domestic violence.

It was a summer Sunday night, and Dr. Jennifer Witt was the on-call trauma surgeon in the St. Luke's Emergency Department when a member of the St. Luke's family arrived via ambulance.

Members of the St. Luke's Domestic Violence Task Force include employees from all across St. Luke's, as well as community partner organizations like Safe Haven Shelter and Resource Center and Program for Aid to Victims of Sexual Assault (PAVSA).

After losing one of their own to domestic violence, the people involved in her care that night were determined to take action. The Domestic Violence Task Force began as a small group, gathering to grieve and work towards ensuring what happened to their friend and colleague never happened in their community again. It wasn't long before that small group grew.

"The outpouring was enormous," says Dr. Witt. "We were all feeling a sense of loss. There were just so many who wanted to help and to heal."

Though it had been over a decade since a life had been lost to domestic violence in Duluth, one in three women will be affected by domestic violence at some point in their lives, and 33% of all female homicides nationwide are committed by the woman's partner.

Meeting monthly in the St. Luke's Foundation conference room, the Domestic Violence Task Force has been hard at work. They've created comprehensive education for employees, revamped the intake process for patients so anyone who feels unsafe at home can find help and safety at St. Luke's, and spearheaded collaborative efforts with 17 area schools to educate the next generation on the dangers of domestic violence through curriculum funded by St. Luke's Foundation.

"Our goal is to ensure people know help is available, and can

be reached privately, quietly and anonymously," says St. Luke's Security Manager Mike Mock. "Our focus is to ensure people in these relationships know they are not alone and help is available in many forms. There are experts and people who care; who can help them get the guidance or other assistance they might need." From such tragic loss, the Domestic Violence Task Force is working to make a positive change for those affected by domestic violence.

"Even if one patient outcome is different – just one –" says Dr. Witt, "then we've achieved our goal."

A COMMUNITY CONCERN A COMMUNITY SOLUTION



How St. Luke's and over 40 area partners turned a mission to provide better community mental health care into a statewide collaboration.

"Through conversations with our mental health professionals, emergency department physicians and nursing leadership, it became clear the problem was bigger than St. Luke's."

-Sue Hamel, Vice President and Chief Nursing Officer, founding member of the Clarity Project At the 2016 Bridge to Health conference, participants identified mental health as a major issue of concern in Northland communities. The 2019 Duluth Community Health Needs Assessment also determined that mental health was a top priority for the community to address. The Clarity Project is now a regional collaborative, working to address the gaps in the continuum of mental health care—and crisis care, specifically.

While there is still much to be done, the ongoing work of the collaborative has led the fight to improve access to quality and appropriate mental health

care resources at the right time and in the right place. An example of the good work this group is doing was reflected when elderly parents and their adult daughter presented to the St. Luke's Emergency Department late one winter night. They were living in their car, having recently lost their apartment. They had medical complications that included dementia and diabetes, and were struggling to manage their mental health. Thankfully, the St. Luke's team was prepared and knew the available resources they could turn to. Staff from the Human Development Center met with the family and set them up in

a local motel where they would be safe and warm. They were assigned case managers and a Homeless Case Management Team to coordinate housing. The parents were moved to a facility that could meet their medical needs. Their daughter gained an apartment, a job and stability in her continued care.

St. Luke's Foundation is a proud supporter of this initiative. This community concern needs a far-reaching community response, and The Clarity Project continues to pursue a comprehensive answer.

ENHANCING OUR CARE THROUGH TRAINING

How a high-tech mannequin helps train the St. Luke's team, regional providers and our community first responders.

Take one mannequin. Add air bladders for lungs with a compressor in the leg. Wire up speakers and realistic, beating pulses that you can hear and actually feel in the wrists, neck and thigh. Include sensors and controllers to dilate pupils and accelerate heart rate. Fill that mannequin with enough technology to let a medical team practice real-world procedures in a low-stakes environment.

That's SimMan® 3G—a human simulator that offers cutting-edge training in emergency care

procedures. "He meets people where they're at," says Eric Barto, Director of Education & Patient Care Services. Health education plays an important role within St. Luke's. Our state-of-the-art Simulation Lab offers healthcare providers, and those throughout our region, the opportunity to train in a controlled environment to develop essential skills that benefit patients.

The 2019 Circle of Light Fund-A-Need raised \$94,150 to purchase SimMan® 3G, whose advanced cardiac and vascular functionalities offer the opportunity to gain and hone life-saving skills.

"He allows for training that is fully customizable and as close to the real world as possible," says Barto, "SimMan makes a real difference in patient outcomes." "It's very close to the real thing. You're on the spot and feel pushed to perform, even if a real patient's health isn't in the balance."
